Macquarie Bank Limited - Macquarie Bank Capital Notes 3 Offer Closes

SYDNEY, 27 August 2021 - Macquarie Bank Limited (ASX: MBL) ("MBL") today announced that it has closed its offer of Macquarie Bank Capital Notes 3 (the "Offer") ("BCN3") on 24 August 2021. MBL issued 6,548,480 BCN3 at an issue price of A\$100 each, raising A\$654.848 million.

BCN3 are expected to commence trading on the ASX on a normal settlement basis on Monday, 30 August 2021, under the ASX code "MBLPD".

Allocation Policy

Broker Firm Offer and Institutional Offer:

Allocations to Syndicate Brokers and Institutional Investors were determined under the Bookbuild completed on 4 August 2021.

Allocations to individual Broker Firm Applicants by a Syndicate Broker were at the discretion of that Syndicate Broker.

Securityholder Offer:

Valid Applications received under the Securityholder Offer were accepted in full.

The total allocation for the Securityholder Offer is \$A154.848 million.

Holding Statements

CHESS and issuer sponsored Holding Statements indicating the number of BCN3 allocated to successful Applicants are expected to be dispatched by Thursday, 2 September 2021. Refunds for any over payment are also expected to be dispatched by this date.

Applicants can confirm their holding before receiving their Holding Statement in the following ways:

Institutional Investors have already been advised of their allocations.

Any successful Applicant wishing to trade their BCN3 prior to receiving their Holding Statement is responsible for confirming their allocation to ensure they do not sell any BCN3 that they do not own. Any person who sells BCN3 before receiving their Holding Statement does so at their own risk.

First Distribution Payment

Distributions on BCN3 are scheduled to be paid on 7 March, 7 June, 7 September and 7 December each year (or the next business day if not a business day), commencing on 7 December 2021. The record date for the first BCN3 distribution is expected to be 22 November 2021.

The Distribution Rate for the first Distribution is 2.4841%.

Issue Date VWAP

For the purposes of the BCN3 Exchange calculations, the Issue Date VWAP is A\$161.16.

Tax Ruling

As noted in the Prospectus, MBL applied for a class ruling to confirm the Australian tax consequences for certain holders of BCN3. The ATO is expected to issue this class ruling shortly in the anticipated form. A copy of the class ruling will be made available at macquarie.com and on the ATO website at www.ato.gov.au.

Participation by related parties of MBL

In compliance with ASX requirements, MBL advises that 3,200 BCN3 were issued to directors of MBL and their associates in aggregate.
